2. **Skill Development / On-the-Job Training (OJT) / Internship**




3. **Employability Opportunity**

6. **Intellectual property**



9. Termination of Contract



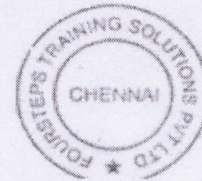


