Memorandum of Understanding


This Memorandum of Understanding (MoU) is entered into and executed on this day of the 21/12/2017.

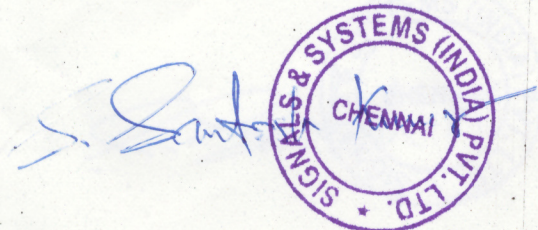


As required, **JCE and SANDS** shall collectively be referred as "**Parties**" and individually JCE as **Party-1** and SANDS as **Party-2**.

**Party-1** intends to avail the below mentioned Services of SANDS and SANDS has expressed its interest in accepting the assignment from 21/12/2017 to 20/12/2018 for a period of 1 Year.

Both the parties agree to be governed by expressing the following terms and conditions in writing.

**Terms and Conditions:**

1. **Party-1** shall organize at least one domain based "**GUEST LECTURE**" every semester which shall be handled by expertise from SANDS at their College as a value added Services.
2. SANDS shall allow students and staffs of **Party-1** for regular "**INDUSTRIAL VISIT**" forgiving them Industrial exposure at SANDS premises with nominal fee.

Both the parties can renew the contract to a mutually agreed period after the completion of the present contract.


**Termination:**
