Circular



Ragging means display of noisy, disorderly conduct, doing any act which causes or is likely to cause physical or physiological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution, and includes.

- (i) Teasing, abusing or playing practical jokes on, or causing hurt to such student,
- (ii) Asking the students to do any act or perform something which such students will not carry out in the ordinary course, willingly,.

Ragging is totally prohibited in any institution.

PUNISHMENT INCLUDES

- (i) Two year imprisonment
- (ii) Fine to the tune of Rs.2.00 lakhs
- (iii) Dismissal from the education institution
- (iv) Shall not be admitted in any other education institution
